Excerpt of the letter Joy and
Marsha have written to Federal
Minister of the Environment J.
Wilkinson.

In June 2019, the federal government announced that Canada will ban harmful singleuse plastics as early as 2021. As well, Canada is to establish targets for companies which manufacture or sell plastics to be responsible for their products and packaging waste.

An update regarding the government environmental plan was revealed in mid-May 2020. We understand efforts to slow the spread of the novel coronavirus in Canada will slow Canada's ability to move on some of the environmental goals. It was indicated that work will continue on a number of elements of the environmental plan but some plans have been delayed.

GASP members are concerned whether the ban on single-use plastics may be delayed. We strongly encourage that the national ban on single-use plastics remain on track for 2021.
