East Antarctic ice shelf collapses. Australian bushfires depleted part of ozone layer. Canada's 2030 Emissions Reduction Plan (ERP) is country's first legally mandated climate plan. Canadian Environmental Law Society says small nuclear reactors are a dangerous distraction from climate action. Open Letter from Nobel Peace Prize Laureates and citizens of the world against war and nuclear weapons

March 20 - Four ways the war in Ukraine could derail climate action. World's banks have amorally worked to build Russia's oil and gas industry - Biden has asked them to stop. **Watch the spiralling rise of world average temperature [here](#)**. Judy Black's TEDX talk about story telling and climate change. Bill for climate change will come 50 years from now. Canada exports 80 per cent of our crude production - we ignore Scope 3 emissions - hypocrisy! Our oceans store about 90 per cent of our planet's heat and they are hotter than ever.

March 6 2022 - GASP stands with the people of Ukraine. 60% of Russia's exports are oil and gas - let's go renewable! We are not on track for a resilient future. Every choice we make impacts the future of the planet.

Burlington Mayor says: “Our farms are under constant pressure from urbanization in this region and those pressures will only get stronger the more growth comes.” (58 delegations.) **Nature’s resilience**: science shows how fast carbon cuts can stabilize temperatures in 3-4 years, Seth Klein notes that governments in Canada are **doubling down on the extraction and export of oil and gas**, Imperial Oil raises dividend amid highest level of crude production in more than 30 years, Canadian taxpayers should not be expected to subsidize the cost of CCUS development, Banks pour trillions into fossil fuels, Bay du Nord project is a **carbon bomb**.

[Feb 6](#) - Snowy Oakville protest to save farmland, Ottawa study showed that low density development **costs \$465/person** annually, whereas **high density saves \$606/person annually**. Residents pay ongoing maintenance costs in perpetuity, while developers profit up-front. 88,000 acres of land within urban boundaries across Greater Golden Horseshoe already approved for housing — enough to meet Ontario’s provincial growth projections for decades to come. Ontario is responsible for 22% of Canada’s GHG emissions. With Ont gov’t weak climate plan, the province and Canada will fail to meet its target. Gordon Laxer’s report on *How Big Foreign Oil Captures Canadian Energy and Climate Policy*.

congestion, Western Canada's deadly heat wave. Climate change - #1 health threat (Lancet, World Health Org'n), Case for climate optimism (Guardian)

[June 26](#) - Rachel Carson quote, Climate Emergency video, IPCC warns about climate tipping points, lawyers define Ecocide, Ont. gov't muzzles critics, the need for legislation on Mining, Canada has most polluting vehicles in world.

[May 21](#) - Douglas Tallamy's term "*Home grown national park*" when half your property consists of native plants. International Energy Agency (IEA) calls for no new fossil fuel investment! Small homes and multi-unit dwellings will help reach climate targets. The message behind the *Home Grown* advocacy campaign to save farmland by Ontario Federation of Agriculture (OFA): "Once it's paved over, it's gone forever."

GASP co-founders on Zoomer TV, Corporate Knights give Ontario a C- for climate action, Green-washing - Prime Minister Justin Trudeau says climate change is an "existential threat," Canada's emissions have increased since the 2015 Paris deal due to Tar Sands exploitation. Scientists are startled at the rate of BC's disappearing glaciers. Only **3.5 %** of registered Canadian vehicles are electric, What's Canada's bestselling vehicle today? The Ford F-150 truck. Hitting climate targets involves building smaller homes and more multi-family units, Small farms deliver better yields and biodiversity,

[May 8 – Mother's Day Issue - 2021](#) - Carole's published letter "A Mother's Day call to climate action," Need for public education on climate action, Seth Klein says: "Tell the truth about the severity of the crisis." Richest 10% of the world's population were

responsible for 52% of the cumulative carbon emissions from 1990 - 2015. Build publicly supported housing on municipal land banks - great housing solution!

[April 30](#) - Trudeau proposes weakest emissions target at Leaders' Climate Summit. Canada - only G7 country with rising emissions since 2015. Bill C-12 - no urgency.

[April 23](#) - Earth Day Issue - Pale Blue Dot (Carl Sagan), Lorraine's letter to RBC - #1 funder of climate chaos, Dalai Lama and Nobel Laureates say: "Keep fossil fuels in the ground." Research shows how Canada can reduce GHG's.

[April 16](#) - "2050 net zero" is a PR stunt to keep the environmental plundering system in place, Greta says: "Activism is needed even more than science... we need to educate everyone." Canadian Environmental Protection Act (CEPA) recognizes in federal law the right to a healthy environment. In 2020 alone, Canada's federal government announced at \$18 billion in subsidies for fossil fuel companies. BUT Government's new climate plan commits \$15 billion to climate initiatives – *spread over ten years*. Bill 257 gives Ont. gov't unchecked power to fast-track development on precious farmland.

[April 10](#) - Carbon pricing is great but the federal gov't supports 20% increase in oil production and 17% increase in gas production. The Federal Greenhouse Gas Offset System gives a break to heavy industrial emitters - credits bought from other emissions-reduction initiatives.

Eight of Ontario's most powerful land developers own thousands of acres of prime real estate near the proposed route of the controversial Highway 413. MZOs threaten Ontario's finite resource — farmland. Ontario can't afford to prioritize haphazard urban development over prime food-producing farmland.

[April 2](#) - Seven young climate leaders launched a legal fight for a safe climate - Nov 2019, Greater Toronto and Hamilton Area activists fight Doug Ford's urban sprawl plans. Canada is a rogue climate polluter - see charts. Only G7 country polluting well above 1990 baseline. A price on carbon rewards innovation, reduces costs and slows a climate breakdown. We need a fossil fuel-free energy future. Call for a basic income.

[March 26](#) - Chief Justice said the federal government is free to impose minimum pricing standards because the threat of climate change is so great that it demands a coordinated national approach. New federal Conservative leader Erin O'Toole insisted: "Climate change is real." The party's grassroots voted against this! Mark Carney believes every financial decision should take climate change into account. Canada's big five banks are among top funders of fossil fuels. Air pollution costs Canada \$120 billion/year,
